Conditions for the validity of Fire Safety Certificate:

1. Fire Safety Certificate is valid for Ground & One Upper Floor only. Small Basement should not be used for any purpose failing which FSC should be treated null & void.
2. All the fire safety arrangement provided therein shall be maintained in good working conditions at all times.
3. Loss of life or property due to non-functional fire safety measure shall be at the responsibility of the Management.
4. The trained fire fighting staff should be available round the clock.
5. Any deviation with regard to the construction etc shall be verified by the concerned building sanctioning agency.
6. Basement shall be used strictly as per building by-Laws.
7. This certificate cannot be treated in any case for regularizations of unauthorized construction, if any.
8. The owner / occupier shall apply for renewal of this Fire Safety Certificate to the Director in Form 'J' [sub rule (1) of rule 37] along with a copy of this Certificate, six months prior to its expiry".
9. The owner / occupier shall submit a declaration every year in form "K" provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on www.dfs.delhigovt.nic.in.
